

## **Medskl.com Apple AirPods and Starbucks Gift Card Contest**

1.1 Eligibility: The medskl.com Apple AirPods and Starbucks Gift Card Contest (the “Contest”) is open to all residents of Canada and to residents of the U.S. who have reached the age of majority in their Province or State of residence, except residents of Quebec and except employees of medskl.com, faculty members who have contributed to medskl.com and any other medskl.com affiliates (“Customers”).

1.2 Contest Period: Starting on 9:00 a.m., Eastern Time, October 5th, 2018 to 11:59 p.m., Eastern Time, October 31st, 2018.

1.3 Customers may participate in the Contest by registering for a free account on medskl.com. Upon registering an account, eligible Customers will be automatically entered into the Contest for one (1) chance to win the Prizes. Customers are restricted to one entry per customer. Medskl.com users who registered before the start of the Contest and who are eligible according to the contest rules will also be entered into the Contest if said user sends an email to [contest@medskl.com](mailto:contest@medskl.com) indicating interest in participating in the contest.

1.4 Awarding of Prize: The Prize will be awarded to the Customer whose name is chosen at random from those Customers who participated in the Contest. Each Customer can only win one prize.

1.5 Prizes: There will be 4 prizes awarded: 1 Apple AirPods (the specifications of the AirPods prize will be at sole discretion of medskl.com, and subject to availability) and 3 x CAD\$25 gift certificates for use at Starbucks stores.

1.6 Odds: The odds of being randomly selected to win a Prize depend on the total number of eligible entries received during the Contest Period.

1.7 Prize Draw: The Prizes will be awarded by random computer generated draws from all eligible Contest entries received during the applicable Contest Period, with the draw to be held on or before November 30, 2018.

1.8 Notification of Selection: The selected Customers will be contacted by e-mail using the email address provided by Customer at time of entering the Contest at least three (3) times within the fourteen (14) days after the Draw. If the selected Customer cannot be contacted in that time, another Customer will be randomly selected and the initial selected Customer will be disqualified and will have no recourse towards medskl.com or anyone involved in the Contest. In order to win, the selected Customer must first correctly answer, unaided, a mathematical, skill-testing question to be administered by telephone or via email, and he or she will be required to sign a standard Declaration and Release Form confirming compliance with the Contest Rules, acceptance of the Prize as awarded and releasing medskl.com from all liability relating to the Contest. No substitution for, or transfer of the Prize, will be allowed. The selected entrant will have seven (7) days from the date of receipt to return a signed copy of the Declaration and Release Form to medskl.com or its representative. If the selected Customer does not do so within this period of time, another Customer will be randomly selected and the initial selected Customer will be disqualified and will have no recourse towards medskl.com or anyone involved in the Contest.
