MEDSKL LIVE AirPods Contest

1.1 Eligibility:

The MEDSKL LIVE Airpods Giveaway (the "Contest") is open to all residents of Canada and to residents of the U.S. who have reached the age of majority in their Province or State of residence, except employees of MEDSKL, faculty members who have contributed to MEDSKL and any other MEDSKL affiliates ("Customers").

1.2 Contest Period:

Starting at 5:00 p.m. EDT, on April 24th, 2020 to 11:59 p.m. EDT, on May 24th, 2020.

1.3

Customers may participate in the Contest by utilizing the Gleam.io widget hosted on medskl.com/airpods-medskl-live to meet the eligibility requirements to win the Prize. Entries will be awarded to Customers by taking the actions described within the Gleam.io widget. Customers are restricted to twelve (12) entries per customer; one entry for registering an account at medskl.com, one entry for joining the MEDSKL group on Facebook as a member, and one (1) entries for each Customer successfully referred to the contest, up to a limit of 10 entries. To be considered eligible to win the Prize, Customer must meet the following criteria at the time of the draw:

- 1. The Customer must have an active medskl.com account, registered to the same e-mail address provided to the Gleam.io widget for the purpose of the Contest.
- 2. The Customer must have an active Facebook account that is a member of the MEDSKL Facebook group.

The selected Customer must answer a skill testing question containing a four-part mathematical test.

If the selected Customer fails to meet both criteria at the time of the draw, another Customer will be randomly selected. The initially selected Customer will be disqualified and will have no recourse towards MEDSKL or anyone involved in the Contest.

1.4 Awarding of Prizes:

The Prizes will be awarded to the Customer whose entry is chosen at random from those customers who participated in the Contest. The draw will be conducted in MEDSKL office in Kingston. 1.5 Prizes:

1.6 Odds:

The odds of being randomly selected to win a Prize depend on the total number of eligible entries received during the Contest Period.

1.7 Prize Draw:

The Prizes will be awarded by random computer-generated draws from all eligible Contest entries received during the applicable Contest Period, with the draw to be held at the MEDSKL office in Kingston, on May 29th 2020 at 12:00pm EDT. Once a Customer is selected, their name will be removed from the following draws, in accordance to one prize per customer restriction.

1.8 Notification of Selection:

The selected Customers will be contacted by e-mail using the email address provided by Customer at time of entering the Contest at least three (3) times within the fourteen (14) days after the Draw. If the selected Customer cannot be contacted in that time, another Customer will be randomly selected and the initial selected Customer will be disqualified and will have no recourse towards MEDSKL or anyone involved in the Contest. In order to win, the selected Customer must first correctly answer, unaided, a mathematical, skill-testing question to be administered by telephone or via email, and he or she will be required to sign a standard Declaration and Release Form confirming compliance with the Contest Rules, acceptance of the Prize as awarded and releasing MEDSKL from all liability relating to the Contest. Contest Period. If an entrant holds a pre-existing medskl.com account, the entrant/user can gain an entry to the contest by visiting the website www.medskl.com utilizing the Gleam.io widget. If an entrant is an existing member of the MEDSKL group on Facebook, the entrant/user can gain an entry to the contest by visiting the Facebook group https://www.facebook.com/groups/MEDSKL/ utilizing the Gleam.io widget. Customers with a pre-existing medskl.com account or who are a member of the MEDSKL group on facebook will still be required to meet the other requirements for eligibility.
